

# YARD DUTY AND SUPERVISION POLICY

## GEORGE STREET PRIMARY SCHOOL

### PURPOSE

To ensure school staff understand their supervision and yard duty responsibilities.

### SCOPE

The principal is responsible for ensuring that there is a well-organised and responsive system of supervision in place during school hours, before and after school, and on school excursions and camps.

This policy applies to all teaching and non-teaching staff at George Street Primary School, including education support staff, casual relief teachers and visiting teachers.

School staff are responsible for following reasonable and lawful instructions from the principal, including instructions to provide supervision to students at specific dates, time and places.

### POLICY

#### Before and after school

George Street Primary School's grounds are supervised by school staff from 8:40am until 3:30pm. Outside of these hours, school staff will not be available to supervise students. These times will be displayed in our newsletter from time to time as a reminder to parents.

Before and after school, school staff will be available to supervise the school basketball court and bus stop after school.

Parents and carers should not allow their children to attend George Street Primary outside of these hours. Families are encouraged to contact Jane McCulloch on 55 71 1478] for more information about the before and after school care facilities available to our school community.

If a student arrives at school before supervision commences at the beginning of the day, the principal or Business Manager will, as soon as practicable, follow up with the parent/carer to:

- advise of the supervision arrangements before school
- request that the parent/ carer make alternate arrangements.

If a student is not collected before supervision finishes at the end of the day, the principal or nominee staff member will consider whether it is appropriate to:

- attempt to contact the parents/carers
- attempt to contact the emergency contacts
- contact Victoria Police and/or the Department of Health and Human Services (Child Protection) to arrange for the supervision, care and protection of the student.

School staff who are rostered on for before or after school supervision must follow the processes outlined below.

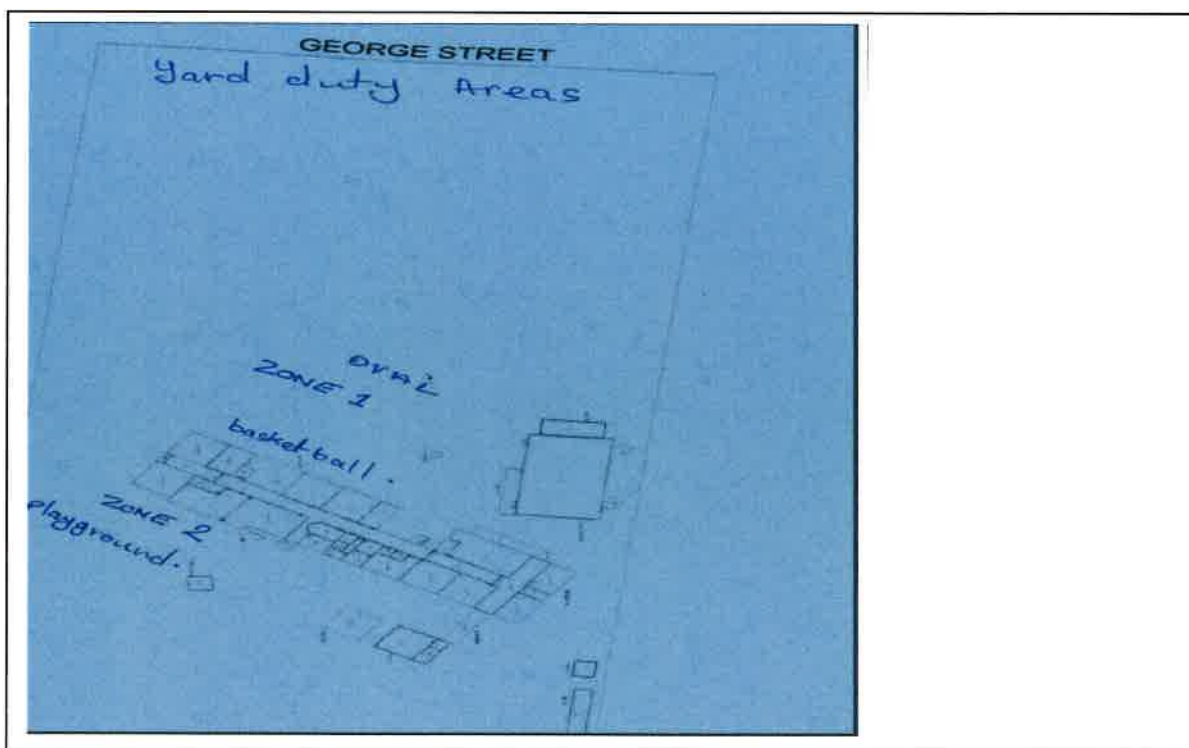
### Yard duty

All staff at George Street Primary School are expected to assist with yard duty supervision and will be included in the weekly roster.

The principal or principal's nominee is responsible for preparing and communicating the yard duty roster on a regular basis. At George Street Primary, school staff will be designated a specific yard duty area to supervise.

The designated yard duty areas for our school as of Term 1, 2018) are

Zone	Area
Zone 1	Basketball Crt /Oval
Zone 2	Playground /shaded area
Zone 3	Quiet Area



School staff must wear a provided safety/hi-vis vest whilst on yard duty. Safety/hi-vis vests will be allocated in Term 1. Please also collect bum-bag, with basic first aid supplies.

Staff who are rostered for yard duty must remain in the designated area until they are replaced by a relieving teacher.

During yard duty, supervising staff must:

- methodically move around the designated zone.
- **ZONE 1**
- Please ensure you move around the basketball court and oval, along the gym pathway and quiet area. Children must not be outside the art room where they can not be seen.
- be alert and vigilant
- **ZONE 2**
- Please walk around the playground, watching the car-park and side road at all times.
- intervene immediately if potentially dangerous or inappropriate behaviour is observed in the yard
- enforce behavioural standards and implement appropriate consequences for breaches of safety rules, in accordance with any relevant disciplinary measures set out in our school's *Student Engagement and Wellbeing* policy
- ensure that students who require first aid assistance receive it as soon as practicable
- log any incidents or near misses as appropriate [i.e. in a Yard Duty Book, on Clear Track, please also keep your own copies of incidents.
- if being relieved of their yard duty shift by another staff member (for example, where the shift is 'split' into 2 consecutive time periods), ensure that a brief but adequate verbal 'handover' is given to the next staff member in relation to any issues which may have arisen during the first shift.

If the supervising staff member is unable to conduct yard duty at the designated time, they should contact another staff member to arrange a swap or contact the principal with as much notice as possible prior to the relevant yard duty shift to ensure that alternative arrangements are made.

If the supervising staff member needs to leave yard duty during the allocated time, they should contact the principal but should not leave the designated area until the relieving staff member has arrived in the designated area.

If a relieving or next staff member does not arrive for yard duty, the staff member currently on duty should send a student in to the principal and not leave the designated area until a replacement staff member has arrived.

Should students require assistance during recess or lunchtime, they are encouraged to speak to the supervising yard duty staff member.

### Classroom

The classroom teacher is responsible for the supervision of all students in their care during class. It is not appropriate to send students in your care out to another teacher, remember you are responsible for your students at all times.

If a teacher needs to leave the classroom unattended at any time during a lesson, they should first contact the principal for assistance. The teacher should then wait until another staff member has arrived at the classroom to supervise the class prior to leaving.

### School activities, camps and excursions

The principal and leadership team are responsible for ensuring that students are appropriately supervised during all school activities, camps and excursions. Appropriate supervision will be planned

for special school activities, camps and excursions on an individual basis, depending on the activities to be undertaken and the level of potential risk involved.
